

Recommended Use(s) and Comments:

1. The primary use at this facility has been occasional community uses indoors and considerable outdoor recreation activity with adjacent soccer field, basketball court, skate park (seldom), playground and small gazebo with benches.

- 2. Access control to the facility seems to be a concern Limited records on uses.
- 3. A community volunteer maintains primary control of activity within the building.
- 4. The addition of a computer lab at this center may bring added benefits if the center can be opened on a regular schedule for its use.
- 5. After school and youth programming available at Mesquite Elementary school, two blocks away.
- 6. Property could be good candidate for sale, short term rental, or long term lease.
- 7. May be able to use the Commercial Kitchen for Business Incubator Activity.
- 8. Legislative appropriation in place to fund PC Lab.
